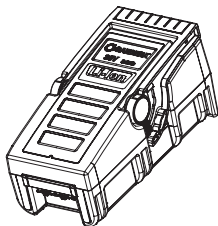

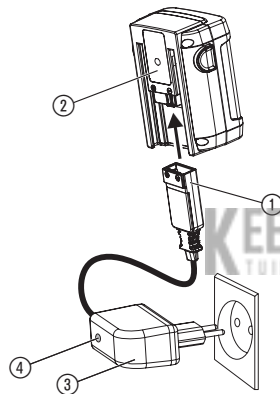

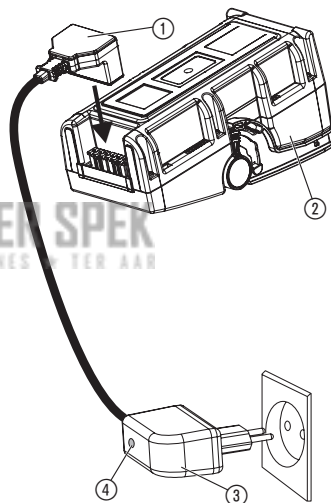

Translation of the original German operating instructions.

Please read these operating instructions carefully and observe the notes given. Acquaint yourself with the use of the battery, the charging technology (see operating instructions GARDENA Rechargeable Battery unit) and observe the safety instructions.

For safety reasons, children under the age of 16 as well as people, who are not acquainted with the instructions should not use the battery. Persons with reduced physical or mental abilities may use the product only if they are supervised or instructed by a responsible person. Children must be supervised to ensure that they do not play with the product. Never operate the product when you are tired, ill or under the influence of alcohol, drugs or medicine.

→ Please keep these operating instructions in a safe place.

1. Area of application of your GARDENA Replacement Battery

Proper use as directed:

The rechargeable battery is used as a power supply for the relevant GARDENA cordless appliances and is intended for use in private house and hobby gardens. The replacement battery must not be used in public facilities, parks, sports grounds, next to roads or in agriculture or forestry. Observance of the operating instructions provided by GARDENA is a prerequisite for correct use of the rechargeable battery.

2. Safety Instructions

→ Please observe the safety instructions on the battery.



FIRE RISK! Short-circuit!

→ **Do not bridge the contacts of the battery with metal components.**

Check your replacement battery before each use:

Visually check the battery before each use. A damaged battery must be disposed of and must not be posted or transported.

Use / responsibility:

Attention! For risks of injury the battery must not be used as power source for other devices. Only use the battery for the GARDENA appliances intended.

Electrical safety:



FIRE RISK!

→ **The battery to be charged must be placed on a non-flammable, heat resistant and non-conductive surface while charging.**

Keep corrosive, flammable and easily combustible objects clear of the battery charger and the battery.

Do not cover the battery charger and the battery while charging. Unplug the battery charger immediately in the event of smoke formation or fire.

Only original GARDENA Charger Units may be used for charging.

The use of other battery chargers may damage the batteries irreparably and even cause a fire.



RISK OF EXPLOSION!

Protect batteries from heat and fire. Do not leave on radiators or expose to strong sunshine for long periods.

Only use and charge the battery in ambient temperatures of between 5 °C and 45 °C. Allow battery to cool down after long periods of use (cooling time up to 1 hr.). An excessively hot battery cannot be charged.

The charging cable should be checked regularly for signs of damage or ageing (brittleness) and may only be used if it is in perfect condition.

Storage:

Do not store the battery above 45 °C or in direct sunlight. Ideally, the battery should be stored below 25 °C so that self-discharge is low. Never store while still attached to a tool, this prevents misuse and accidents.

Do not store the battery in places where static electricity is present.

Warning! This machine produces an electromagnetic field during operation. This field may under some circumstances interfere with active or passive medical implants. To reduce the risk of serious or fatal injury, we recommend persons with medical implants to consult their physician and the medical implant manufacturer before operating this machine. Do not use the product when a thunderstorm is approaching.

Danger! Small parts could be swallowed during assembly and there is a risk of suffocation from the polybag. Keep infants away during assembly.

3. Initial Operation

Charging the battery (see page 2):



ATTENTION!

Overvoltage damages batteries and the battery charger.

→ **Ensure the correct mains voltage.**

Before using for the first time, the battery must be fully charged.

The lithium-ion battery can be charged in any state of charge and the charging process can be interrupted at any time without harming the battery (no memory effect).

1. Plug the plug of the charger cable ① into the battery ②.
2. Plug standard charger ③ into a mains power socket.

**Charging control lamp ④ is lit red:
Battery is being charged.**

**Charging control lamp ④ is lit green:
Battery is fully charged.**
(For charging time, see 7. Technical Data).

Check the charge status regularly while charging.

3. Once completely charged, disconnect the battery ② from the battery charger ③. Disconnect the battery ② from the battery charger ③ first, then unplug the battery charger ③.

4. Storage

Storage / overwintering:

The battery must be stored out of the reach of children.

1. Charging the battery.
2. Store the battery in a dry place.



Li-ion Disposal of batteries:

The GARDENA battery contains lithium-ion cells that should not be discarded with normal household waste at the end of their life.

Important:

Please return the lithium-ion batteries to your GARDENA dealer or dispose of them properly at a public recycling centre.

1. Discharge lithium-ion cells completely.
2. Dispose of lithium-ion cells properly.

5. Maintenance

Make sure the surface and the contacts of the battery always are clean and dry before connecting the charging unit. When dirty clean them with a soft, dry rag; never use running water.

6. Troubleshooting

Error messages of the error-LED (see page 2) Art. 8835.

Problem	Possible Cause	Remedy
Device stops and the error-LED flashes.	1. Battery Overload.	Wait 10 sec. When the warning LED doesn't flash, start again.
	2. High temperature. The allowed operation temperature was exceeded.	Wait approx. 15 min. When the warning LED doesn't flash, start again.
Device stops and the warning-LED doesn't flash.	Battery is discharged.	Charge the Battery.

In the event of faults, please contact GARDENA Service.

Repairs must only be carried out by GARDENA service departments or specialist dealers authorised by GARDENA.
